

Rules – Open Futurity

American Saddle Horse Breeders Futurity of Wisconsin, Inc.

GENERAL PROVISIONS

DIVISIONS AND HOW SHOWN – The ASHB Open Futurity of Wisconsin will be held each year in four divisions: WEANLINGS and YEARLINGS shown IN HAND, TWO-YEAR-OLDS shown in FINE HARNESS, and THREE-YEAR-OLDS may be shown either in PARK PLEASURE (Mares & Geldings only) or FINE HARNESS. **The Three-Year-Old Park Pleasure class will be stripped.** All classes will be shown under the rules of the U.S. Equestrian Federation.

SHOWING PROCEDURE FOR IN HAND ENTRIES – Entries will be led into the ring shown in bridle or halter without quarter boots, blinkers, blindfolds or other appliances, one at a time showing at a trot, be led down the right-hand rail to the other end of the ring, return to the judges at a trot, and then be judged on conformation. On the return lead, entries are permitted to trot past the judges to the end of the ring, if so desired, and then return to the judges. Entry will then be led to the opposite rail at a walk, out of the way of subsequent entries. Entries are not to be judged lunging. **Plastic or paper bags are not permitted. Ginger is not permitted.**

SIRE NOMINATION – To nominate a stallion to the Wisconsin Open Futurity it is necessary:

1. That the stallion be registered with the American Saddlebred Registry.
2. That a fee of \$75.00 be paid to the Wisconsin Futurity on or before June 15 each year a foal is born.

DAM NOMINATION – To nominate a mare to the Wisconsin Open Futurity it is necessary:

1. That the mare be registered with the American Saddlebred Registry.
2. That a fee of \$20.00 be paid to the Wisconsin Futurity on or before June 15 each year a foal is born.

NOTE: In the year of nomination, the donor mare must be nominated for each foal/embryo that she will produce that year. A \$20.00 dam nomination fee, per foal/embryo will be due on or before June 15.

IT IS THE RESPONSIBILITY OF THE MARE OWNER TO VERIFY THAT THE SIRE OF THE FOAL HAS BEEN NOMINATED

ALL LIMITED BREEDERS STAKE WEANLINGS MUST BE NOMINATED TO THE OPEN FUTURITY

WEANLING ELIGIBILITY – To keep a weanling eligible to show in the Wisconsin Open Futurity, the following conditions must be fulfilled:

1. The sire and dam must be nominated to the Wisconsin Open Futurity by June 15 of the year in which the foal is born.
2. A weanling fee of \$50.00 must be paid to the Wisconsin Futurity on or before June 15 of the year the foal is born.
3. In order to show, a copy of the registration papers must be presented to show management. Any misrepresentation automatically disqualifies the entry.
4. If not shown as a weanling, the foal must be registered by December 31 of the foaling year to maintain eligibility. Pending applications (including DNA testing) must be completed by March 31 of Yearling year.

YEARLING ELIGIBILITY – To keep a yearling eligible to show in the Wisconsin Open Futurity the following conditions must be fulfilled:

1. The horse must have been nominated as a weanling, in the Open Futurity and all conditions and requirements must have been fulfilled.
2. That a fee of \$50.00 to be paid to the Wisconsin Futurity on or before June 15 of the yearling year.

TWO-YEAR-OLD ELIGIBILITY – To keep a two-year-old eligible to show in the Wisconsin Open Futurity the following conditions must be fulfilled:

1. The horse must have been nominated to the Open Weanling and Open Yearling Futurity and all conditions and requirements for a weanling and yearling must have been fulfilled.
2. That a fee of \$50.00 to be paid to the Wisconsin Futurity on or before June 15 of the two-year-old year.

THREE-YEAR-OLD ELIGIBILITY – To keep a Three-Year-Old eligible to show in the Wisconsin Open Futurity, the following conditions must be fulfilled:

1. The horse must have been nominated to the Open Weanling, Open Yearling and Open Two-Year-Old Futurity, and all conditions and requirements must have been fulfilled.
2. That a fee of \$50.00 must be paid to the Futurity before or on June 15.

PRIZE FUND – The value of the prize fund of the Wisconsin Futurity each year shall be the total amount of money paid in fees, miscellaneous funds, added donations, and interest, less administrative costs.

DISTRIBUTION OF PRIZE MONEY – The nominator of the Sire and Dam of the Weanling Champion will receive \$50.00 each. The nominator of the Sire and Dam of the Reserve Weanling Champion will receive \$25.00 each. The remaining prize money shall be divided equally between Weanling, Yearling, Two-Year-Old and Three-Year-Old divisions. The Weanling Division and Yearling Division will consist of one class each. In the event the Two-Year-Old Fine Harness Class or Three-Year-Old Park Pleasure or Three-Year-Old Fine Harness class(s) are split- the prize money will be paid out in the finals. Monies allocated to the Three-Year-Old division will be divided evenly among the two classes. In each class **first place will receive 30%, second 20%, third 15%, fourth 10%, fifth 9%, sixth 7%, seventh 5% and eighth 4% of the purse.** All prize money shall be paid to the recorded owner on show date. All prize money allocated to each class will be paid out regardless of number of horses shown. An IRS 1099-Misc Form will be sent to all money winners.

LIABILITY – No entry is liable for more than the amount paid in, but there will be no return of payment. The right is reserved to reject any entry and bar any entry from competition for failure to comply with the conditions of this futurity.

THE WISCONSIN FUTURITY AND ITS BOARD OF DIRECTORS CANNOT BE HELD RESPONSIBLE FOR THE ACCURACY OF PREVIOUSLY NOMINATED HORSES. IT IS THE OWNER/NOMINATOR RESPONSIBILITY TO CAREFULLY REVIEW ALL PREVIOUSLY FUTURITY NOMINATED HORSES BY RETAINING COPIES OF PREVIOUS NOMINATIONS.
